- For 2024 we will do our utmost to organise again a physical (hybrid?) workshop!






Guidelines during online meeting





Ease logging into the meeting







Did you face technical problems?





Opinion on length of meeting and no. of breaks



Satisfied with options for raising questions?




Remark (2022):



Scores:


